ELIGIBILITY & REQUIREMENTS

The show is open to all members of PAOA at the time of entry submission and date of show.

Two-dimensional traditional fine art portraiture of the human form and figurative works (no erotica) may be entered in any medium (oil, acrylic, watercolor, mixed media, charcoal, pastel, etc.). May include animals, but main feature of artwork must be human. Works completed within the past three years and not entered into previous PAOA annual exhibitions are eligible. Works must be original in conception by artist and the original artwork, no giclees. Photo reference for work must have been taken by artist. No master copies or copies of copyrighted photography. Must not have been created under the supervision of an instructor.

Works must be properly framed. Unframed gallery-wrapped stretched canvases (stapled on back) and cradled panels with a minimum depth of 1 1/4" should be painted on all sides. Must have eyescrews (preferably D-rings), wired, and ready for hanging. No sawtoothed hangers allowed. Mats must be neutral in color, clean, and professional in appearance.

All artwork is to be labeled on back with artist name, title, and price. It is the Artists' responsibility to charge a consistently fair price for work entered, not exceedingly overpriced or underpriced.

- Works submitted for exhibit must be for sale or marked NSF.
- Sales of artwork will be the responsibility of the artist. Buyers must contact artist directly. Provide current contact information.
- Artist agrees to pay a commission of 20% of the sales price to University Club.
- Work must remain hanging for the duration of the exhibition.

SUBMISSION GUIDELINES

1. Complete the Entry Form and Sign "Holds Harmless" below.
2. Entry Fee: \$30 for up to 3 works, and \$10 for each additional work entered, no limit. However, no more than 3 works may be accepted into the show. Make checks payable to PAOA.
3. The Jury process is dependent upon the submission of quality images of your artwork. Poor quality photography or improper preparation of your images, may result in disqualification. Submit a JPG for each piece sized to 72 dpi, with a maximum of 1,000 pixels on longest side. Images should be cropped to exclude extraneous backgrounds or frames and adjusted for color correctness and quality. Jurying is done from your images. CDs will not be returned. Prints or slides will not be accepted.

IMPORTANT: Images must be sized correctly in order to be visible in our system. If you need assistance in this requirement, please contact Linda Fox at lfoxart@yahoo.com.

Each image must be labeled with the title of piece and your first initial and last name, e.g.: PortraitofErin_JDoe.jpg

6. Notification of acceptance of artwork and instructions for delivering your artwork to University Club, will be sent via E-mail. You must provide a working E-mail address.
7. Pick-up of artwork at the close of the show is the responsibility of the artist. There is no storage for artwork left.
8. Only members may enter. You may join PAOA prior to or with your entry. \$45 for membership dues good through Dec. 31, 2016.

Failure to comply with these guidelines may result in disqualification of your entries.

I understand that the University Club, PAOA, or any of their representatives will not be held liable for any damages, loss, theft, or injury which may occur during any/all activities of this exhibition. PAOA reserves the right to refuse any/all work submitted. I approve the use of images of my artwork for University Club and/or PAOA publications and promotional material. I understand that PAOA will not be responsible for damages to or loss of submission materials. I will be responsible for the sales of my artwork and agree to pay the University Club a 20% commission of the sales price. I hereby agree to all these terms.
